Subject: Revised Application Format and the Procedure for Transfer of name of registered veterinarians from one state register to another (under Section 52 of IVC Act 84) – regarding.

Sir,


With the approval of the Veterinary Council of India(VCI) New Delhi, it has been decided that henceforth, the transfer process of registration of veterinarians from one State Veterinary Council (SVC) to another State Veterinary Council (SVC) shall be routed through first named State Veterinary Council and for this purpose a standard application format will be used.

The procedure for transfer of registration will be as defined below:

- The applicants will use the Standard Transfer Application Form (in bilingual) available on the official website of the Council www.vci.dadf.gov.in
- The application will be submitted in TRIPLICATE (1 Original + 2 copies) to the Registrar of first named State Veterinary Council (after duly filling the details in Part (1) and (2) of the applications).
- The application form shall be accompanied with the requisite fees, as prescribed in the Indian Veterinary Council Act, 1984; drawn in the name of the second named state veterinary council.
- The Registrar of first named State Veterinary Council will verify the records and issue NOC (Part-3) for the transfer of registration and forward two set of application along with original DD to the office of the VCI for further consideration.
- In the event of first named SVC not agreeing to transfer of registration, may record the same and intimate the applicant.
- The office of the Secretary, VCI may recommend for the transfer of the registration of the applicant from the first named SVC to the second named SVC and order to the effect. The original DD along with the copy of the application will be forwarded to the second named Council for further actions.
- The Registrar of the second named Council shall complete the due formalities of registration and will allot new number to the applicant and shall intimate the applicant and the Registrar of the first named SVC under intimation to VCI.
- However, there will be no change in the initial date of registration of the applicant and the details will be maintained for records at the second named SVC.

The revised procedure is expected to facilitate verification of records and timely disposal of transfer applications. The Registrars of all State Veterinary Councils are hereby requested to strictly adhere to revised procedure from the date of issue of the Circular. The VCI appreciates, timely implementation of the process.
