**Eligibility :-** The person/Bidder should have Valid Account No and G.S.T. No., Pan No., Adhar No. and last Three year Return file for which proof has to be given in the office of the Council.

**General Information :**

- (i) The person/Bidder shall submit their quotation/rates along with EMD of Rs. 3000/- Identity Proof of Owner, Address Proof of owner/bidder, Copy of Pan Card, Copy of Service Tax/GST Certificate if available and Banks details.
- (ii) The Committee constituted by the Secretary, VCI shall finalize the bid on the basis of Highest Bidder price and other terms and conditions of this Bid.
- (iii) In case of failure of Bidder H-1, the H-2 will be given opportunity to lift the material on quoted rates. Further, EMD amount of bid shall be forfeited in case of bidder fail to accept the bid on quoted amount.
- (iv) Selection of the Bidder will be at the sole discretion of Secretary, Veterinary Council of India.
- (v) Bidder on receipt of the acceptance letter has to arrange for the weighing the items in presence of the representative of Veterinary Council of India at the premises of this Council.
- (vi) Bidders may visit the office between, 22 November 2021 to 30 November 2021 during the office hours and inspect the items proposed for auction.
- (vii) On arrival of the weight/sale value, the full amount of auctioned items should be deposited through NEFT or RTGS to the bank account of the Veterinary Council of

India Account No. \_\_\_\_\_ IFSC Code \_\_\_\_\_ within same day or next working day and shall present a proof of such remittance. Thereafter, Bidder shall be allowed to lift the scrap material.

- (viii) Period of lifting of material/scrap items will be two working days including all formalities of weighing and deposit of full amount of the auctioned items. In case of failure or not completing the work within prescribed period, EMD will be forfeited.
- (ix) Earnest Money of the unsuccessful bidders will be refunded after finalization of the complete process of bid and completion of auction.
- (x) In case of H-1 or H-2 declines the offer, for whatsoever reasons, the EMD will be forfeited and next bidder shall be given an opportunity to complete auction.
- (xi) Any tax is leviable shall be paid by the successful bidder/persons.
- (xii) Veterinary Council of India will not be liable for provide container/carrriage/weighing formalities, if any. It will be managed by the bidder only on his own cost & discretion. The cost of carriage/container/weighing formalities shall not be allowed to deduct from the total cost of bid amount. It is to be bear by the bidder at their own cost.
- (xiii) Veterinary Council of India shall not be responsible financially or otherwise for any injury to the bidder or person deployed by the bidder in the course of performing the disposal activity.
- (xiv) Any dispute and difference arising out in any way shall be referred to the Secretary, VCI and Secretary, VCI shall be the competent authority in the matter. Any Dispute shall be subject to Delhi jurisdiction only.
- (xv) The Secretary, Veterinary Council of India reserves the right to reject any , all or any bid/quotation without assigning any reason thereof.
- (xvi) Bidder has to submit their bid price in the prescribed format in Annexure –B which is enclosed herewith.
- (xvii) Deviation of bid format may lead to rejection.
